### **Bylaw Updates**

- Rolling Substitutes please read separate handout
- Single Game Vouchers increased to a maximum of 4 per player per season to run inline with finals player qualifications (remaining at 5 games)
- Best & Fairest Votes players who transfer between Clubs during the season will no longer have their votes transfer with them to their new Club/team.
- Netball Victoria Transgender and Gender Diverse Policy bylaw wording updated to reflect Southern FNL supports participation as per the Policy. A copy of the policy can be found on the Netball Club Hub.
- Clearances updated required for player movement between Clubs in the last 12 months
   (rather than 24 months). This was updated to reflect the functionally in Netball Connect, please
   check your clearances online once per week. If any clearances have not been actioned within 7
   days, they will be automatically approved.
- Match Day Squad Lists updated to 12 players maximum listed per game. Team lists can be updated in the Teams module of Netball Connect.
- Players added to the scoresheet once match has begun any breaches must be actioned by team officials & umpires on the spot during the game. There will not be any penalties postgame.
- Relocating Games (due to injury) A 3 minute guideline whereby officials shall make a decision
  on whether a game should move courts (where possible) where an injured player cannot be
  safely moved. This is introduced to avoid time loss during a break of play.
- A1-A4 Promotion/Relegation From the 2025 season onwards, divisions A1-A4 will be held to
  promotion/relegation protocols whereby the premiers of divisions A2-B1 will be promoted to
  the division above and the team finishing lowest on the ladder from divisions A1-A4 will be
  relegated to the division below. Additional team movements may be made via direct division
  swap upon the agreement of both Clubs. Divisions A1-A4 will have 8 teams.
- Player Points/Points Restrictions as per Policy circulated last year. A spreadsheet will be shared per Club with player details for the 2024 season.

### **Home Games/Refixture Requests**

 2024 fixtures to be shared shortly. No further Home Game requests will be facilitated by the League. Any future changes must be agreed upon by both Clubs and information given to the League 3 weeks prior to the fixtured change. There is no pressure on Clubs to decline any requests that are not already facilitated by the League.

- All Home Games must abide by the requirements outlined by the league including Court Supervisors, Match Day Checklist, Umpires and First Aid. Documentation can be found on the Netball Club Hub.

### **Umpiring**

- Introduction of our new Head of Netball Umpiring, Brad Keats. Brad will be looking after all things umpiring including communication, allocation of umpires and coordinating our mentors.
- Umpires will no longer be allowed to umpire/play 3 games in a row unless given permission by Netball Match Day Staff.
- Umpires are due to be supplied by Clubs on March 4 this is so that umpires can receive accurate communications from the League regarding meetings and workshops.
- At this stage, we do not have numbers to host an Introduction to Umpiring Workshop. Kingston District NA is hosting an in person workshop on Sunday March 3 where Club's new umpires should attend. The League will reimburse these costs to the umpire.
